The reporting documents include activities for Year 2 and plans for Year 3. While we work on our diversity and equity plan and a continuous hearing screening plan (for children up to age three years), the due date has been extended, by HRSA, for one year.

Available services include connecting with the Regional Colorado Hearing (CO-Hear) Resource Coordinator and the progress monitoring tool that is available through CU-Boulder. The task force members are discussing ways to message the information about UHL that can be distributed by the diagnosing audiologist. This would include up-to-date information and contact information for the Regional CO-Hear Coordinator. Task force members are also discussing messaging to PCPs about UHL as they, too, discuss UHL with parents.

Summary of Discussion: For the past eight months, task force members have discussed the transition of children from Part C to Part B services. The task force members have a document with recommendations that will be shared with CDHS.

Christy Scott reported that CDHS is in the final stages of creating an agreement between CDE and CDHS as Child Find services, for children birth to three years of age, move from one agency to another. There is a longer transition period specifically for children with sensory disabilities (e.g., DHH, BVI, DB).

Diagnostics/Identification Task Force	

Date: September 17, 2021

Summary of Discussion: NCHAM has a new training curriculum for screeners. This curriculum is being recommended by the virtual site visit (VSV) team as they meet with birthing facilities.

Two VSVs have been conducted. Six more are planned before March 31, 2022. Our VSV team represents the 1-3-6 EHDI system and includes: a parent, the EHDI Director, a clinical audiologist, the Regional CO-Hear Coordinator, a PCP, and an ENT. By representing the full 1-3-6 system, we are addressing a long-standing recommendation to provide opportunities for regional collaborations throughout the EHDI system.

Going forward, the VSV team will look for diversity in the next six birthing facilities who receive VSVs. We are seeking facilities with geographic diversity; those that do, and do not, contract for screening services; size diversity; and the presence, or not, of an onsite clinical audiologist. In preparation for the next set of VSVs, the team is reviewing the NCHAM documents and tailoring them for our own use.

The VSV team aims to encourage adherence to best practices, according to JCIH documents, by birthing facilities. The role of COEHDI in this initiative is not to offer surveillance. Rather, we are gathering themes to support our educational efforts. We are fortunate to have University of Colorado-Boulder AuD students and LEND trainees supporting our efforts.

Notably, it is not clear as to which agency in the State is responsible for surveillance of NBHS activities. Leanne Glenn reported that the definition of surveillance adopted by CDPHE is to collect data and share it in HIPAA-compliant ways. Another definition of surveillance is to observe in order to gather evidence. COEHDI staff are clear that we have the responsibility for education. The definition of surveillance, and the agency responsibility for it, may be a topic that is better suited to the CIHAC.

CDPHE is supporting VSVs by announcing the opportunity for birthing facilities to participate in their HIDS Monthly Bulletin.

COEHDI staff have been messaging The Ascent Program in novel ways in our newsletter. We are also considering ways to share The Ascent Program with the 20 CCBs statewide as all early interventionists are contracted through them.

Members of this task force are encouraged to participate in other task forces. The members of this task force reported that timing does not always allow for this. And, DHHDB adults reported that they are not always comfortable with language that is used in the other task forces.
