Announcements	Virtual Site Visits (VSVs): To date, 2 VSVs have been completed. Our VSV team met with the audiologist at a third birthing facility; a second VSV will be scheduled to include the Nurse Manager. The VSV team is in the final stages of adapting the NCHAM materials for site visits in CO. During VSVs, the team is also focusing on education about cCMV. We plan to complete 8 visits by early April and we will analyze themes based on these collective site visits. The birthing facilities we are scheduling were identified, in large part, by CO-Hear Coordinators. If any task force members want to suggest we visit with a particular birthing facility, please let Arlene know the name of the facility.			
Continuous Screening Plan	 HeadStart and Early HeadStart have a mandate for hearing screening. DPS is actively involved in this and LIsa Cannon has been working with Denver area hospitals and local health clinics. Some have purchased OAEs. There are published CDE guidelines for continuous screening: <u>Click Here</u>. Will Eiserman from NCHAM offered input into the draft plan for continuous screening that was shared today. Sandy Gabbard and Lisa Cannon reported on existing initiatives for continuous screening. The COEHDI plan will incorporate what is currently being done. A suggestion was to "get the word out" to pediatric healthcare settings. Wyoming has an annual screening directive that is run though their regional health department offices.
