EHDI Updates	<ul style="list-style-type: none"> <li>● <i>Ascent Video</i>: A draft of the short version of the video was shared with the group and an update about the completion of the longer version</li> <li>● <i>Family-to-Family Support</i>:               <ul style="list-style-type: none"> <li>○ Data was just collected again and an interesting note is a dramatic increase from CO H&amp;V that they are reaching out to families of children when their child turns 3 to connect them to resources as they transition.</li> <li>○ COEHDI is also funding a Spanish-speaking parent guide, OAE equipment for midwives, updating of the <i>Roadmap</i>, and support for the virtual site visit process</li> </ul> </li> <li>● <i>Diversity &amp; Inclusion Plan</i>: A D&amp;I plan was created over the summer that focuses on Spanish-speaking families who live in rural areas. Families are currently being interviewed to identify strengths and gaps in their experiences with the EHDI system.</li> <li>● <i>Virtual Site Visits</i>: Information was shared about themes emerging from the virtual site process that COEHDI is conducting with birthing facilities.</li> <li>● <i>UHL Infographic</i>: Through the work of the Diagnostic Task Force, a UHL infographic was created to encourage families to follow-up for a child who is experiencing a unilateral hearing difference. This resource is available in English &amp; Spanish and can be found on the COEHDI website. These will be distributed in paper form to audiologists in addition to it being sent out electronically.</li> </ul>
